Whiskey Creek Civic Association: MTSBU Median Maintenance Initiative Median numbers are listed in order from #1 to #18, starting at the McGregor entrance (#1) and going east to south/east towards the College entrance (#18). Currently the existing MTSBU covers medians #1-#17. The WCCA is requesting that median #18 also be added to the existing MTSBU. #18 is currently under control of and in complete disrepair. Adding #18 will enhance the neighborhood and give consistence and appeal to the entire community. MTSBU Median Maintenance Initiative: Maintenance Checklist (check all that apply) Write the median number below. A committee assigned by the Whiskey Creek Civic Association was tasked with taking a detailed overview and inspection of all 18 medians along the main throughfare of the Whiskey Creek Neighborhood. The committee took notes and pictures of what they viewed and kept the mindset of "consistency throughout the community" when taking notes and pictures.

In no particular order, there were a few on the initial comments and concerns:

- The entrance appears dated and shows sign of ware. Cracking in the stucco and broken signage and lettering. (both entrances – McGregor and College)
- 2. Overgrown mature trees that appear to have outlived their useful life.
- 3. Mature trees that have been mis-shaped from past storm events.
- 4. Landscaping that does not have consistency from median to median.
- 5. Dirt/sod erosion on nearly every median. The level of the grass/landscaping is far below the curb cut.
- 6. Sprinkler system appears to be inadequate. Multiple areas of either insufficient watering or over watering.
- 7. Overgrown palm trees and other vegetation near stop signs and intersections could pose a threat to both automotive and pedestrian accidents.

The committee is making the following recommendations to the Whiskey Creek Civic Association Board:

- McGregor and College Entrance / Signage complete refit of the entrance in regards to the concrete structure, signage, wall, plumbing and electrical systems, and paint. A quote for a reputable GC and design company should be collected to complete the necessary work.
- 2. The landscaping in the very front of the McGregor Entrance is sufficient, however, everything behind the sign needs replaced (this will be very consistence moving forward with the rest of the recommendations).
- 3. For a all medians 1-18:
  - a. Keep all mature Royal Palm Trees
  - b. Keep all mature Oaks. Trim and shape where needed.
  - c. <u>Keep</u> all other mature trees that still have an adequate useful life and do not pose a threat to vision at intersections.
  - d. Add additional landscaping to hide electrical/pump stations/and/or other unsightly objects.
  - e. IN ADDITION TO THE ABOVE, ASSUME THAT ALL BOXES ARE TO BE CHECKED FOR ALL MEDIANS LISTED IN THE PREVIOUS PAGE.

Tidewater Landscape has provide a bid and scope of work. See attached. Open for discussion regarding the bid.

The committee recommends receiving another bid for a similar scope of work so that the WCCA board can make a recommendation.

The committee recommends a detailed bid for what the expense would be to trim all mature trees in accordance with our recommendations.

Upon receipt of the following information, a more formalized and detailed report shall be submitted to the the WCCA board and then a meeting can be arranged with Bob Beville at the MSTBU.
