• 2) Increase the previously approved budget of \$50,000 to \$52,858 - Approved – All board members provided a unanimous email vote.

• Project Total Tidewater \$26,743

• Project Total Extreme Painting \$26,115

• Total Expense \$52,858

• 3) Paint color – No clear decision was made on paint color. Cole will discuss all options with Extreme and seek advice on the best direction based on color and longevity.

Good morning,

If I may make one recommendation, I think you should wait for spring before placing any new plantings. Due to the current and anticipated drought conditions, the irrigation will need to be reduced, and I would hate to see any new planting not take root as a result. It's up to you of course, but I would not recommend planting now.

Additionally, keep in mind that no lanes can be closed during season, so the contractor must be able to complete their work without lane closures.
